You will all remember the horrific devastation of the Kashmir earthquake in October 2005 where amongst other horrors, 6,000 schools were destroyed. Third World Solidarity (TWS) in tandem with Jhok aid Project (registered charity) has been working overtime to replace just one of these schools – to be re-named The Kensington & Chelsea School – which is a difficult but worth while task.
